

Payment Options

DIRECT DEBIT: Payment is collected from your bank account on or around 23 days from the invoice date. Further information can be obtained by contacting us on 03442 480 777 or visiting our website at www.dhl.co.uk/directdebit. Select the Direct Debit link.

MYBILL: If you are registered for MyBill, payments can be made online via the MyBill hub. To sign-in or register for MyBill, please visit www.dhl.co.uk/mybill

INTERNET / TELEPHONE BANKING: If you have access to the internet or telephone banking, payments can be made to: Sort Code 40-02-50, DHL Bank Account number 91406396. Please quote your DHL Customer number and/or Invoice Number as a reference to ensure that DHL can match your payment to the invoice. The IBAN code is: GB33 MIDL 400250 91406396 and the Swift code / BIC number is: MIDLGB22.

CREDIT OR DEBIT CARD: You can settle your account using any major UK registered Credit or Debit Card. To pay by Credit or Debit card please call 03442 480 777. Alternatively you can make a payment online at www.dhl.co.uk/epayments

AT THE BANK: You can make a payment directly at the bank using an invoice giro slip or by quoting DHL bank details: Sort Code 40-02-50, DHL Bank Account number 91406396. Please ensure the bank has entered your Invoice number and/or Customer number in their system as a 'Customer Reference', to ensure we can match your payment with your invoice. Please allow 4 working days for the payment to clear your account.

Invoice information

Volumetric weight: You may be sending a large, light weight shipment where its volumetric weight exceeds its actual weight. If so, the cost of the shipment is calculated on the space your consignment takes up.

Export by Air

To calculate the volumetric weight of your shipment multiply the length x depth x width of the shipment package and divide the result by 5,000 if you have measured in centimetres and 305 if you have measured in inches.

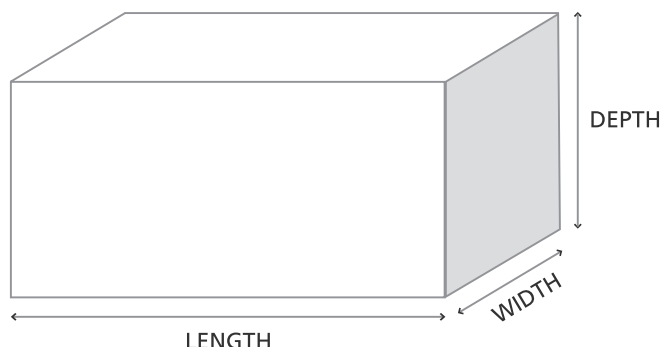
For example, assume the actual weight of your shipment is 7kg, but the volumetric weight is:

$$\frac{50\text{cm} \times 40\text{cm} \times 30\text{cm}}{5,000} = 12\text{kg}$$

In this example the volumetric weight of 12kg is greater than the actual shipment weight.

Export by Road

To calculate the volumetric weight of your shipment multiply the length x depth x width of the shipment package and divide the result by 5,000 if you have measured in centimetres and 305 if you have measured in inches.
